## Special Program for Sponsoring Afghan Refugees

Under Canada's Private Sponsorship of Refugees program, Groups of Five and Community Sponsors must submit a Refugee Status Determination document issued by the United Nations High Commissioner for Refugees (UNHCR) or a foreign state with their sponsorship application.

However, IRCC has recently announced a temporary public policy that enables Groups of Five and Community Sponsors to sponsor Afghan refugees who do not have a refugee status document.

This temporary public policy recognises the vulnerability of Afghans who fled Afghanistan due to the collapse of the government of Afghanistan and the close ties between the people of Afghanistan and Canada. It aims to facilitate the resettlement of Afghan refugees under the PSR Program. IRCC will accept applications under this public policy from October 17, 2022, until October 17, 2023, or for up to 3,000 Afghan refugees (whichever comes first).

The sponsor who signs the refugee sponsorship application submitted under this public policy must attend a mandatory RSTP training and include a copy of their attendance certificate with the application package for the application to be considered complete. ### FAQs about the Special Program

# **1.** Q: When should applicants submit applications for Sponsoring Afghan Refugees?

A: You can apply to sponsor through this program starting **October 17, 2022, at 12:01 (EDT Ottawa Time)**. Send your complete application to the email address or mailing address listed in the instruction guide

2. Q: How can applicants prove that they are outside Afghanistan if they don't have any documents from the UNHCR or local government of the country of asylum?

# Q: Can donations to the funds held in trust come from donors outside of the group or even outside of Canada?

A: Yes, donations can come from sponsors who are not group members. And contributions can come from donors who are outside Canada. Key things to remember:

- Funds cannot come from the refugees being sponsored, even if they have enough money for sponsorship. Funds must be raised by sponsors in Canada.
- Groups must provide a detailed explanation about how the funds were gathered.
- We recommend including a note from the donors with their names and contact info, confirming that they contributed funds and their motivation. We would also recommend asking donors to provide the following information:
- Proof of transaction from their account to the sponsorship account
- Any financial documents they are comfortable sharing – ideally a Canadian Notice of Assessment (if in Canada) or an equivalent (if outside Canada)
- It is up to the sponsor to provide evidence to IRCC that the funds did not come from the refugees being sponsored, so we recommend being very detailed and providing as much information as possible.

8. Q: Can criminal record checks obtained through thirdparty providers be submitted with the application?

A: Applicants must indicate their current address in the application forms. And in Schedule 2, applicants will have to provide detailed information about why they fled and details of their journey from their country of origin to their country of asylum.

# 3. Q: Can I sponsor as a G5 member if I have already sponsored another refugee family?

A: Yes. Sponsors can commit to sponsoring multiple refugees/ refugee families, provided sponsors have enough funds (if they contribute funds), availability, and time to support all sponsored refugees with settlement and integration. We recommend enclosing a cover letter explaining how this sponsor plans to assist and settle all the sponsored applicants.

#### 4. Q: Can one G5 sponsor multiple applications?

A: Yes, it is possible, but the group must make sure they have enough funds and sufficient capacity to support all sponsored applicants/ families

# 5. Q: Can the same sponsor be part of several Groups of five (G5)?

A: Yes, it is possible, but the sponsor must realistically assess their funds and their capacity (their time and availability) to be able to support all the applicants who are being sponsored. Please add a cover letter indicating that you are also sponsoring as part of another G5 and explaining how you will be able to provide support to all sponsored newcomers. A: Yes, IRCC confirmed that they accept third-party criminal record checks.

Q: Can a sponsorship application be submitted with proof that a criminal record check has been requested, and then the criminal record check be submitted later?

A: No, this is not possible. If you apply without a valid criminal record check or any other mandatory document, your application will be returned or rejected for being incomplete.
